We will approach our work and the challenges we encounter with flexibility. Responding to the needs of our clients, we will start with openness, looking for where and how we can be helpful. Our responses can be "outside the box" creative, and draw on the resources around us.

# WHO WE ARE

The Legal Help Centre (LHC) is a non-profit organization with charitable status that has been serving the community since 2011. LHC was developed to address a gap in providing access to justice for disadvantaged people and communities.

LHC is a source of legal information and guidance. We take the time to listen to clients, and to help them understand their situation. We identify options and potential solutions, and give people the right tools to address their legal issues and move forward with their lives. We emphasize creating an accessible, welcoming place for people to receive assistance, for students to learn skills, and for volunteers to participate in giving back to the community.

#### **Our Collaborative Approach**

At LHC, we recognize that legal problems often intersect with social and economic issues. We know that dealing with a legal issue can impact a person's life in many ways - legally, financially, emotionally and physically. That is why we use an interdisciplinary approach to problem solving. We host students from the faculties of law, social work and criminal justice and, if an individual has other concerns related to their legal problem, we work together to try to assist by providing information, support and helpful referrals to other resources.

We work together with a variety of community organizations to help individuals deal with the complex dilemmas they face. If we can refer a client to another agency that is better suited to help them with some part of their problem, we do! If we can cooperate with others to improve an individual's involvement in the legal process, enhance the information provided to the public and empower people to deal with their legal matters, we will and we have! If we can create opportunities for students to get practical experience and develop skills that will help them be successful in a career of helping others, we definitely do!

Legal Help Centre is honoured to work on Treaty One lands, the original territories of the Anishinaabe, Cree, Oji-Cree, Dakota, Lakota, Dene peoples, and the homeland of the Red River Métis.

We acknowledge our role in the many relationships that make up our home and commit to a spirit of reconciliation for the future and actively seeking the truth for the past.

# STRONGER WITH CHANGE

#### A message from the Board President

Friends of the Legal Help Centre,

Former Chief Justice Richard Scott, and now former LHC Board member, said at his last board meeting that "there is no greater honour than serving the public". I could not agree more. This past year has been one of change and we have come through stronger than ever and are in a better position to serve the public. The evidence is in the number of people served over the past year - up from 3,300 in 2021/22 to over 4,400 in 2022/23. We were able to reach more people due to the incredible support we receive from our volunteers and donors which has allowed us to navigate significant change together.

CHANGE #1: When the COVID pandemic changed community service, LHC was compelled to change from inperson clinics to telephone & virtual appointments. This change, while allowing us to reach more people, also hindered legal access for those people who did not have access to telephone & virtual services. After careful deliberation by the staff & board, LHC adopted a hybrid service delivery model in January, combining in-person clinics with telephone appointments, allowing us to reach more people & increase access to justice.

CHANGE #2: Our lease & IT support have been generously donated by the University of Winnipeg for many years. We are so grateful for this support, but the donation will soon end and we are exploring options, including a possible move or to be a part of the redevelopment of Portage Place.

CHANGE #3: We were sad to see Executive Director, Paula Hamilton, leave the organization at the end of February. Her tenure at LHC saw the organization grow by leaps & bounds in spite of a worldwide pandemic that fundamentally changed the way we offered service.

CHANGE #4: We have grown as a team adding a 3rd lawyer, Danielle Magnifico, along with an administrative assistant, Ramatoulaye Ndiaye. Staff lawyer Doug Ripley left and was replaced by Daniel Hildebrand. We were also privileged to employ Aminat Anoba as our articling student and she was called to the bar on June 15th.

CHANGE #5: LHC proudly announced that Nadia Rumore became Legal Director in April 2023. Nadia leads our legal clinic & oversees the experiential learning opportunities for students from a variety of disciplines. Nadia joined LHC in 2017, is inspired by the students' enthusiasm to provide exceptional service to our clients and received the Manitoba Bar Association's 2022 Access to Justice Award.

#### NAVA'S STORY

Nava (not her real name) approached LHC shortly after being served with a Small Claim by her former employer. Nava had worked as a receptionist for a short stint with an employer in a healthcare field. At the end of her second day of work, Nava was presented with a document styled as a "Training Agreement" that purported to require Nava to pay \$10,000.00 in lieu of paid training if she ever opted to leave her employment and work in the same field.

Nava started to feel uncomfortable continuing in her job and found a position better suited to her in the same field. After starting her new job, Nava's first employer alleged that she had violated the agreement she had been compelled to sign (on her second day of work) that required her to pay \$10,000.00. Nava's employer was represented by experienced legal counsel at a large firm, and Nava felt very intimidated by the situation.

LHC students, assisted by staff lawyers, researched the contract and relevant caselaw and determined that Nava could provide a meritorious defence to the Court. LHC agreed to assist Nava with preparing a Book of Authorities for the trial and an LHC staff lawyer and articling student assisted Nava at the hearing. After a month of waiting, the decision came back in Nava's favour and the employer's lawsuit was dismissed. Nava was very grateful for the assistance she received from LHC.

# OUR STUDENTS

Students play a central role in LHC's service to the public and in fact, without them, we would be unable to meet the growing need in the community for legal information, advice, and support.

So while students often say they found their learning opportunity at LHC to be the best part of their university experience, we feel that their contribution is equally invaluable for us. Their eagerness, diligence, and fresh outlook serve as reminders of our mission to help the vulnerable and constantly encourage us to approach clients, questions and issues with curiosity, openness and compassion.

Because of the variety of disciplines we host - law, social work, criminal justice - the students benefit from each other's perspectives when they approach problem solving and they are better equipped to assist a person who is attempting to address their legal and social issues.

#### Reflections

We asked some of our 3rd year law students to give their future selves some advice about their work experience at LHC. Here's what we heard:
